Level 1 - Incident Violations

(non-referred/non-recorded)

Classroom Managed or Staff on Duty Managed

-
- Running
 - Loud Voice/Yelling
 - Off-task behavior
 - Noise making
 - Name Calling
 - Out of Seat
 - Missing homework
 - Chewing Gum/Eating candy (without teacher permission)
 - Low-level technology violation (cell phone out but not in use)
 - Without class materials
 - Indirect inappropriate language
 - Low level disruption

Level 2- Minor Violations

(Non-referred/Recorded as Minor)

Classroom Managed or Staff on Duty Managed

-
- Indirect Disrespect
 - Habitual Defiance
 - Habitual Disruption
 - Physical aggression towards another (no contact made)
 - Habitual indirect inappropriate language
 - Property misuse
 - Dress-Code violation
 - Habitual Technology violation (low-level)
 - Cheating
 - Forgery

Level 3- Major Violations

(Referred/Recorded as Major)

Administrative Managed

-
- Direct Defiance/ Insubordination
 - Physical Aggression (contact made or disrupts the learning environment)
 - Severe disruption
 - Severe disrespect
 - Direct inappropriate language, racial/ethnic slurs, or continued habitual indirect inappropriate language
 - Harassment
 - Bullying
 - Fighting
 - Inappropriate Location (not in assigned classroom)
 - Truancy
 - Theft
 - Intentional tech violation or habitual low level tech violation
 - Property Damage
 - Vandalism
 - Habitual Cheating

Level 4 - Illegal Violations

(Referred/Recorded as Major)

Administrative Managed

-
- Drug use/possession
 - Weapon use/possession
 - Habitual truancy
 - Arson
 - Bomb threat
 - Extreme property damage
 - Combustibles
 - Assaults/Threats



Lincoln Park Elementary School Discipline

Level 1 - Interventions/Consequences

- **Teacher/Student Conference (Get to the root of the problem, Reteach Expectations, etc.)**
- **Call Home**
- Alternate Seating
- Redirection
- Loss of Classroom Privilege

Level 2- Minor Violations Interventions/Consequences

- **Teacher/Student Conference**
- **Call Home**
- **Document in IC (minor behavior tab)**
- Meeting with family and student (Admin can be present)
- Home Visit
- Structured Time Out
- Sit on wall for recess
- Meeting with Dean at the door

➤ Repeating the same level 2 behavior:
4 x's in 4 weeks = Level 3 (must be documented in IC)

Level 3- Major Violations Interventions/Consequences

- **Administrative Conference**
- **Call Home**
- **Recorded in IC by Dean (Major Behavior)**
- Administrative Consequence - recess with Dean, school beautification
- Suspension
 - In School
 - Out of School
- Restorative Practices
 - Mediation
 - Community Connection
 - Small Groups
- Tier 2 MTSS Referral after 3 Major Referrals (must be documented in IC)
- Conference with Counselor
- Loss of Privilege


Level 4 - Illegal Violations Interventions/Consequences

- **Administrative Conference**
- **Call Home**
- **Recorded in IC by Dean (Major Behavior)**
- Parent Meeting
- Counselor
- School Psychologist
- School Police/ Court
- Out of School Suspension
- Behavior Hearing Referral
- SAP Classes
- VIP Classes
- Legal Department
- Administrative Investigation/Threat Inquiry or Assessment
- Alternate Placement





Level 1 Incident





Level 2 Incident



- ACTIONS (Teachers)**
1. Minor Violation
 - Teacher/Student Conference
 - Call Home
 - Enter into IC as a *Minor Behavior*
 2. Repeat Minor Violation in a 4-Week Period
 - Student/Teacher Meeting
 - Call Home
 - Enter into IC as a *Minor Behavior*
 3. Repeat Minor Violation in a 4-Week Period
 - Student/Teacher/Parent/Admin Meeting
 - Enter into IC as a *Minor Behavior*
 4. Repeat Minor Violation in a 4-Week Period
 - Teacher enter into IC as Minor Behavior
 - Admin will notify parent
 - Admin will assign consequences

**Level 3 & 4 Incident
Major & Illegal Violations**



- ACTIONS (Admin)**
1. Level 1 (4th Repeat Minor Referral)
 - Administrative Consequence
 - Loss of Recess
 - Clean School
 - After School Consequence
 2. Level 2 (8th Repeat Minor)
 - In-School Suspension
 - Addition of Level 1 Consequence
 - Re-Entry Meeting/Plan
 3. Level 3 (12th Repeat Minor)
 - MTSS Referral
 - Out of School Suspension
 - Addition of Level 1 Consequence
 - Parent Conference
 - Re-Entry Meeting/Plan
